This award highlights professional excellence in manufacturing and encourages all employees to strive for excellence. It also promotes industry-specific careers to students, parents, educators, government bodies, and other stakeholders.

ELIGIBILITY CRITERIA FOR THE AWARD

NOMINEE REQUIREMENTS:

Employment: Must be employed by a current CA member.

Role and Performance: Must have demonstrated exceptional skill and dedication in an employed role related to composites manufacturing.

Career Development: Must be able to demonstrate ongoing commitment and/or professional development and contribution to the field.

Residency: Must be a permanent resident of Australia in 2026.

Age: Must be above the age of 18.

NOMINATOR (ORGANISATION) REQUIREMENTS:

Membership: Must be a current CA member.

Registration: Should be registered in Australia with an Australian Business Number.

Legal Compliance: Must comply with workplace health, privacy, safety and industrial relations legislation.

Regulatory Compliance: Should have no current compliance issues with the regulator and no adverse issues with any government contracts.

Nomination Approval: Award nominations must be signed off by a senior manager of the Member organisation.

Accuracy of Information: Must confirm that all information in the nomination is true and correct.
